

WAIVER, RELEASE & INDEMNIFICATION

In consideration of the acceptance of my or my child's participation, or the participation of those in my care, in any events, clinics, programs, or activities delivered or hosted by Knights Rugby League Pty Ltd ("the Newcastle Knights"), to the extent permitted by law:

- I understand and voluntarily assume the risks associated with participating in any events, clinics, programs or activities delivered by the Newcastle Knights;
- I waive all claims that I, my child, or those in my care may have against the Newcastle Knights, its officers, directors, members, volunteers, employees, agents, sponsors, or its executors, administrators, heirs, successors, or assigns ("the organisers"), and release them from all claims for death, injury, or damage arising out of our participation in their club, their event, and its related activities, together with any costs, including legal fees.
- I agree to indemnify and keep indemnified the organisers against any damage arising out of my, my child's, or those in my care's participation in the events, clinics, programs, and related activities.
- I agree to comply, and ensure that my child or those in my care comply, with all the rules, regulations, and instructions of the organisers.

In the event of injury or illness during participation, I consent to, and authorise on behalf of my child or those in my care, the receipt of medical treatment, which may be deemed advisable by the organisers.

I acknowledge that I, my child, or those in my care, have sole responsibility for our personal possessions and equipment during all events and activities.

I hereby permit the free use of my, my child's, or those in my care's name and picture in any broadcasts, telecasts, and the press, including websites, as they pertain to the Newcastle Knights, their events, clinics, programs, and activities.

I understand that any registration fee is non-transferable and not refundable.

I agree to have my, my child's, or those in my care's personal details recorded and used by the Newcastle Knights and related parties for further communications about future related events.

RELEASE, WAIVER & INDEMNITY

NOTE: THIS RELEASE FORM IS A CONTRACT WITH LEGAL CONSEQUENCES. PLEASE READ IT CAREFULLY BEFORE AGREEING TO CONFIRM YOUR PARTICIPATION.

I, my child, or those in my care want to participate in any current or future events, clinics, programs, or activities delivered or hosted by the Newcastle Knights. I understand and acknowledge that participation may involve physical risk. I understand that these activities are conducted on fields, and other surfaces whose conditions are variable and unpredictable and in weather conditions and can change without notice, both of which could contribute to the safety of participation and result in serious personal injury.

In consideration of the Newcastle Knights accepting me, my child, or those in my care as participants, I, for myself, my heirs, executors, administrators, successors, and assigns, hereby release, waive, and forever discharge the Newcastle Knights, its owners, sponsors, and all their respective agents, officials, servants, contractors, representatives, directors, elected and appointed officials, successors, and assigns from all claims, demands, damages, costs, expenses, actions, and causes of action, whether in law or in equity, in respect of death, injury, loss, or damage to my person or property, or

that of my child or those in my care, however caused, arising from or to arise by reason of our participation in any events, clinics, programs, or activities delivered or hosted by the Newcastle Knights, whether as spectators, participants, competitors, or otherwise, whether prior to, during, or subsequent to any such activities and notwithstanding that same may have been contributed to or occasioned by the negligence of any of the aforesaid. I further hereby undertake to hold and save harmless and agree to indemnify all of the aforesaid from and against any and all liability incurred by any or all of them arising as a result of, or in any way connected with, our participation in any events, clinics, programs, or activities delivered or hosted by the Newcastle Knights.
